In January, New York became the 10th state that allows adopted adults unrestricted access to their original birth certificate without a court order.

The new law is a shift from state restrictions dating back to the 1930s that required adoptees in New York to seek a order to access their original birth certificate. See <a href="#">AP story here.</a>

keep children safely with their
families and avoid the traumatic
experience of entering foster care.
Family First also seeks to curtail the
use of congregate or group care for
children and instead places a new
